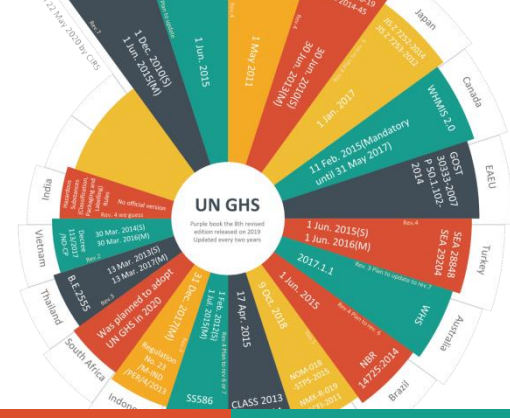

What makes the classification different (September 2, 2020)?

Q1: One SDS can be used for different countries?

A1: It is only possible when the language, classifications of the chemical products are exactly the same in different countries. In many cases, we have to generate SDS according to destination countries' standards. The classifications can be slightly different. The SDS details requirements have to be considered.

Q2: We want to know more about India new REACH regulation for GHS classification.

A2: For India requirements regarding the GHS/SDS, as far as we know, India has been planning for the implementation of GHS for many years. A draft of "Hazardous Substances (Classification, Packaging and Labelling) Rules was released in 2011. This draft has been revised several times, the latest revised version is released early this year. Now we are expecting to see the new rule published.

Q3: How do you handle different required GHS classifications from different countries on SDSs/labels? Different classifications/SDS/labels in each country? What about liability? One SDS that includes the various different GHS classifications or what?

A3: We use a "Classification & Template distinction" method in CIRS.

We re-classify each chemical product according to the different countries' standards. The SDS format is designed according to different regulatory requirements.

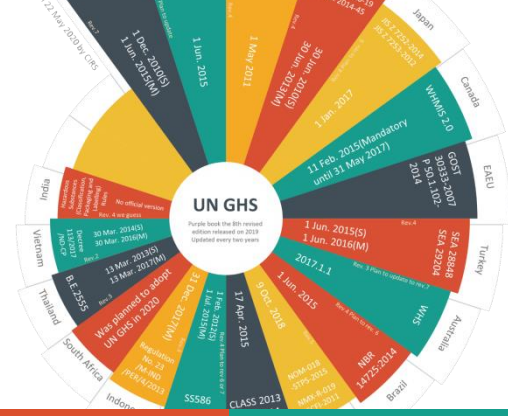
One SDS cannot include different GHS classifications for various regions. We suggest author SDS respectively for different market.

Q4: How do you handle a different listed transportation classification on SDSs/labels, e.g., acute toxicity?

A4: I guess you mean the different listed GHS mandatory classifications which may affect the DG (dangerous goods) class as well? If the mandatory classifications can trigger a stricter DG class, we will suggest to change a DG class to avoid contradiction. The real case can be more complicated, we need to consider more factors, including, if the UN number and DG class is specified for the chemicals, if the package will affect the transport risk, etc.
